Concern:

1. If this plays out similar to what happened a few years ago when ICE did a "saturation" in Booking, it will have an impact on population as it did before (purely for reference/preparation).
2. Additionally, perhaps some discussion for notifying Releasing and/or Records to delay a release while ICE is determining whether or not they will detain an individual. I am concerned that I (or any other Cpl) will unknowingly proceed with a release, that otherwise would be "proper", while the determination is being made. Major Lucas made reference (in J1 Staff) that as compared to the 3-4 hour delay last time, this time the decision will be almost instantaneous, but I can still envision a few scenarios where a release could slip through, which clearly we don't want. The last time, there were numerous times that holds being placed by ICE while the inmate was physically in Releasing and a few moments away from what otherwise would have been a legitimate release.
